\_\_\_\_\_ I possess a valid Texas Drivers License OR I possess another state valid license AND I am in active military service or the spouse or child of someone serving in the military.

\_\_\_\_\_ I do NOT possess a Commercial Driver's License

\_\_\_\_\_ I have NOT taken a driving safety course in lieu of paying a fine in the last 12 months

\_\_\_\_\_ I am not in the process of taking a driving safety course to dismiss another offense

\_\_\_\_\_ I am not charged with going 95 miles per hour or more

\_\_\_\_\_ I am not charged with driving 25 miles per hour or more over the posted speed limit

\_\_\_\_\_ I understand that I have 90 days from the date of the ticket to complete the Texas Education Agency approved course and submit a certificate of completion to the court

\_\_\_\_\_ I understand that if I do not complete the course within the 90 days, I must remit the remainder of the fine and a conviction will be reported on my driving record
